- Concentrate on one area. 'Bring the eye to one area of the painting that makes it easier on the juror," she claims.
- A little bit of humor also makes your work memorable.
- Be emotionally involved in the painting. "There should be a little bit of the artist in it," she says.

How important is it to be selected in a juried show? "Some artists find it not important at all," Black says. "But it's one way of getting work out in front of the public eye. That often leads to work leading work shops, demos and teaching. Art is expensive and you can use that work to supplement the expense."


