Many sell out in advance, so order your tickets early. Below is a guide to upcoming tours in North San Diego and South Riverside counties in order by date.

Artists with the San Dieguito Art Guild have a suggestion for Mother's Day weekend. How about taking mom out for a leisurely gander through colorful gardens and shopping for one of a kind artwork?

Hirschkoff's is one of nine home and gardens showcased in the popular art and garden tour. Named San Diego Home and Garden Magazine's Garden of the Year in 2001, the Hirschkoff garden has also been chosen by the American Association of University Women and San Diego Horticulture for their garden tours.

"It's a lot of work (getting ready for a garden tour),"

said Hirschkoff, "but it's always very rewarding when people are wowed by a garden."

Wow-worthy is a good description of Hirschkoff's garden. Gravel paths wind through two landscaped acres that boast an aviary, koi pond, rose garden, raised vegetable beds, row of palm trees, garden sheds and trellises, as well as bird houses and stained glass.

On the Mother's Day tour, each home will host several guest artists whose work will be for sale. Some homes will also have musical entertainment and refreshments. And all of the artwork on the tour is made by local artists --- nothing is mass produced or imported, said organizers.

"What the artists and hosts look forward to most is having people come on the tour and just enjoying their day," said Guild member Grace Swanson, "Most artists love to talk about their work, their methods, and what inspires them and the hosts love to show off their homes."

Some homes on this year's tour have never before been featured in the annual event, including the homes of sculptor Manuelita Brown, second generation Encinitan Carolyn Cope, Cardiff resident Lindsay Duff and the Leucadia home of Rusty and Donna Loftin.

Also for the first time, the tour will be dedicated to the memory of four mothers of Guild members: Laura Lowenstein, Terry Oshrin, Mary Beck and Grace Swanson. Photos of each mother will grace the cover of a tour souvenir booklet and will include a quote from each of their daughters.

The tour is a self-guided one. Homes will be open from 10 a.m. to 4 p.m. on both Saturday, May 8, and Sunday, May 9. Tickets are available at the Guild's Off Track Gallery in the Lumberyard Shopping Center in downtown Encinitas or at the Guild's website at www.offtrackgallery.com for \$20.

The tour is the guild's largest fundraiser of the year and a portion of the proceeds will be donated to a local school's art department.

Offtrack Gallery prepares for grand opening in new site

The San Dieguito Art Guild opened its first gallery on Highway 101 in Del Mar more than four decades ago. Since then, the nonprofit group of artists has grown to more than 200 members and has operated a gallery in nearly 10 locations from Del Mar to Encinitas. The guild will mark the grand opening of its newest location on April 24 at the Lumberyard Shopping Center in Encinitas.

The guild's Offtrack Gallery lost its space on Second and D streets in Encinites when a dental company bought the building in March. The guild board then voted to sign a five-year lease at the Lumberyard mall, where it already had a second satellite gallery, in hopes that this might be a more permanent home for art exhibits.

"We are excited to be in this new gallery because we have found a permanent home. Moving from location to location takes a lot of time and energy," longtime member Grace Swanson said.

The guild has been on the move since its early days, said Swanson, who has traced the group's history and its numerous moves.

In 1965, Del Mar artist Sue Beere wanted to start an art group, so she called together friends and neighbors to a coffee at her home. They formed the San Dieguito Art Guild and elected Beere as the first president. Some of the founding members had considerable art training, and others had none. The group met in members' homes until a rental space was available. The first 100 members to join the new guild were designated charter members. These included Marjorie La Ray, Kirby Sumner, Lee Woods, Ann Knapton, Mavia L. Shortlidge, Ruth Roebuck and others.

The guild artists began showing their work on the lawn of the Old Del Mar Hotel. They raised enough money from the outdoor shows and commissions from dues and art sales to rent a small shop in downtown Del Mar, called the Blue Lantern, on Highway 101 next to the Chamber of Commerce. In 1966, the group moved into what is now the Del Mar Library, which it rented until 1969.

From there, the group moved into a tudor-style, three-story house known as the "Honeymoon Cottage" that was part of the Old Del Mar Hotel, and then into what is now the Del Mar Civic Center.

In 1975, the guild moved to Leucadia in a building behind the Corner Frame Shop. Then after a year in a building on Vulcan, the guild moved in 1982 into the downstairs of the old train station in Leucadia where the Pannikin Coffee House was and took over the Offtrack Gallery.

The Offtrack Gallery name stuck with the group, even after it moved out of the train station into other locations in Encinities.

Over the years, the gallery locations have changed, but the mission has remained the same: to showcase the work of local artists.

"We want to give emerging artists an opportunity to show their art," said Dave Ombrello, gallery manager. Ombrello was instrumental in securing the new lease and refurbishing the gallery with other volunteers. "The most exciting part of the new gallery is that the artists love it," he added.

The 1,100-square-foot gallery has a contemporary look with an open ceiling and unique wall covering that makes a warm backdrop for the art.

The gallery bills itself as "The Biggest Little Gallery in San Diego," showcasing the work of more than 100 artists in a variety of media - from digital art and watercolor to sculpture and jewelry.

Member artists can display their work for an average of about \$45 a month depending on the size and type of exhibit. The commission charged on sales is 15 percent. Artists who show their work in the gallery take turns staffing it with volunteers.

"Many years of savings have allowed us to have this gallery now," Ombrello said.

The guild's income comes from four sources: annual dues, fees to display art, commissions on art sales, and proceeds from the annual fundraiser - the Mother's Day Weekend Artists' Studio and Garden Tour. The guild received a small grant from the city of Encinitas to fund the "Try It, You'll Like It" workshop. Last month's workshop allowed participants to try three new mediums, including watercolor, fiber arts, photography, gourd art, jewelry and pastels. The guild continues to offer guarterly demos at the gallery, which are free to the public.

"Our goal is to keep the gallery in one location for a long time," Swanson said.

The San Dieguito Art Guild Board and the Gallery Committee enforce these gallery rental policies in order to make it as fair as possible for our rental artists and to open up as many opportunities to our members as possible. The gallery committee has worked very hard to develop policies that they believe provide equal opportunity to all members. We hope that you will find the Off Track Gallery the ideal venue to display your artwork. In order to rent gallery space artists must comply with these rental policies:

- 1. The policies were revised April 1, 2010.
- 2. Potential gallery space rental artists must enter the Monthly Show at least three times prior to jury date.
- 3. Potential gallery space rental artists must present a sample of their artwork to the Jury Committee for approval prior to displaying any artwork in the gallery.
- 4. New gallery space rental artists must schedule and complete training after they are juried into the gallery and prior to first displaying their artwork.
- 5. Gallery renters are required to sign a contract which defines the terms of the gallery space rentals.
- 6. The initial term of the contract is two rotations (four months).
- 7. Displaying artists are required to staff the gallery in which their artwork is displayed. Staffing duties depend on the amount of gallery space rented. One wall space, tower, jewelry cubes, and large 3D cube artists staff two shifts per month. Mini wall space artists staff one shift per month.
- 8. In order to provide every artist an equal opportunity to display their artwork in every area of our galleries all artists will rotate within and between galleries on a one year cycle. There will be six rotations which comprise one complete cycle. Each rotation will last two months. The artist must commit to rent for an entire rotation at the time the rotation begins. The gallery rotation pattern will change as the galleries change. The rotation sequence is located gallery.
- 9. Artists will have one position in the rotation. An artist can be both a wall and floor renter but cannot occupy two wall spaces or rent more than one floor display.
- 10. Artists must make a deposit equal to one month's rent. The deposit will be returned when the artist has fulfilled all of the terms of the contract including giving adequate notice, meeting all staffing commitments, as well as meeting all financial obligations.
- 11. Artists must give a one month notice to vacate their space. This does not supersede the requirement to complete the initial term and the two month rotation.
- 12. At the time of rotation each artist will complete the following:
 - 001. Make payment for the full rotation (Two months).
 - 002. Schedule all of the required staffing obligations. Artists staff the gallery in which their artwork is displayed.
 - 003.Remove their artwork from the last position.
 - 004. Repair any damage and clean the display area.
 - 005.Print wall labels as necessary.
 - 006.Display artwork in new location.
- 13. Commissions are 15%.
- 14. The SDAG is a volunteer organization and relies upon its members to sustain its programs. Each renter is required to sign up and serve on a committee or as board member or committee chairperson. If you currently do not volunteer for a committee you should contact the appropriate chairperson and sign up for one of the openings. Your assignment will be verified prior to displaying your artwork in the gallery. Artists are also required to assist at one rotation.

- · Grace responded that she cannot handle the extra work much longer and that a replacement needs to be sooner rather than later.
- · Judianne then asked if Grace could follow up with Eileen.
- It was agreed to by the Board Members that we need to make sure that the person who assumes this position is qualified.
- Mary said that someone needs to follow up with Deborah Henry. Grace said that she would follow up with Deborah.

4. Replacement of Floor Chair:

Discussion about candidates for the position and what to do for right now.

SDAG BY-LAWS

Amended May 19, 2008 and May 24, 2010

By-Laws for the regulation, except as otherwise provided by statute or its Articles of Incorporation ("Articles"), of SAN DIEGUITO ART GUILD (a California 501 C-4 Nonprofit Corporation)

ARTICLE I PRINCIPAL OFFICE

The Principal Office of the Guild is hereby fixed and located at the Off Track Gallery, 937 South Coast Highway 101, Lumberyard Shopping Center, Suite C-103, Encinitas, California 92024. The mailing address is PO Box 235853. The Board of Directors is hereby granted full power and authority to change said Principal Office from one location to another in the County of San Diego. Any such change shall be noted by the Secretary, which shall not be considered an amendment of these By-Laws.

ARTICLE II MEMBERS

Section 1. CLASSIFICATION OF MEMBERS

Membership in the Guild shall be classified as Regular, Junior, Sustaining, Honorary, Lifetime and Patron.

- a. **Regular Members**. Regular members shall be active participating artists, amateur or professional, in fields of visual art, sculpture, photography, and crafts in the classical sense
- b. **Junior Members**. Junior members shall be all persons under 18 years of age and older than 15 years of age.
- c. **Sustaining Members**. Sustaining members shall be individuals, organizations or businesses showing a sincere interest in art.
- d. **Honorary Members**. Honorary Membership may be given at the discretion of the Board of Directors to those individuals who are not members and who have devoted service to the organization considered to be special and/or sustained.
- e. **Lifetime Members**. The Board of Directors may give a Lifetime Membership to a member who has shown personal sacrifice and devotion to the organization.
- f. **Patron Members**. Patron Members shall be members contributing a minimum of \$500.00 per year to the Guild. They would be exempt from active duties of the gallery and may enter any event without a fee.

Section 2. QUALIFICATION FOR MEMBERSHIP

Application for membership shall be in such form as shall be prescribed by the Board of Directors.

Section 3. TERMINATION OF MEMBERSHIP

A member who fails to pay dues after September 30 will be dropped from the membership rolls. A member may be expelled for conduct, which the Board of Directors shall deem inappropriate for a member. All rights of a member in the Guild and to its facilities and equipment shall cease upon receipt of written termination of membership.

Section 4. DUES

Dues for the various classifications of membership are as follows:

- a. Regular members \$75
- Regular members (family) \$85
- b. Junior members \$40
- c. Sustaining members \$75
- d. Honorary members none
- e. Lifetime members none
- f. Patron Members \$500 Initial contribution per annum

Section 5. RESPONSIBILITIES

Members will contribute a reasonable amount of time towards the operation of the Guild and Gallery by being active members of a committee or the Board of Directors.

Section 6. MEETINGS OF MEMBERS

Annual meetings shall be held on the first Thursday of the month of August at the hour and place designated by the Board of Directors. Special meetings of the members may be held at the call of the Board of Directors or by the President upon petition of 20% of the regular members. Notification of meeting dates and times shall be posted in the Guild's newsletter, The Paint Rag, as well as through electronic communication.

Section 7. VOTING

All members shall be entitled to one vote at any official meeting or electronic vote.

Section 8. QUORUM

Those members attending the General meeting shall constitute a quorum.

ARTICLE III DIRECTORS

SECTION 1. NUMBER OF DIRECTORS

The control and management of this corporation shall be vested in the Board of Directors. The authorized number of Directors shall be fifteen (15) until changed by amendment of the Articles of Incorporation and by amendment to these by-laws. A majority of the Board shall constitute a quorum for the transaction of business.

Section 2. POWERS OF THE BOARD

Subject to the powers of the members as provided by law or as herein set forth, all corporate powers of the corporation shall be exercised by or under the authority of, and the business and affairs of the corporation shall be controlled by, the Board of Directors. Without limiting the generality of the foregoing, the Board of Directors shall have the following powers:

- a. To select and remove all non-elected officers, agents and employees of the corporation.
- prescribe such powers and duties for them as may be consistent with the law, with the Articles of Incorporation or the By-laws, and fix their compensation.
- b. To conduct, manage and control the affairs and business of the corporation and to make such rules and regulations therefore consistent with law, with the The Articles of Incorporation or the By-laws, as they may deem best.
- c. To change the principal office for transaction of the business of the corporation from one location to another within the same county; to fix and locate one or more subsidiary offices of the corporation within the County of San Diego; to designate any place within San Diego County for the holding of any members' meetings; and to adopt, make and use a Corporate Seal and to alter the form thereof from time to time as in their judgment they may deem best, provided such changes shall at all times comply with the provisions of law.
- d. To borrow money and incur indebtedness for the purpose of the corporation, and to cause to be executed and delivered therefore, in the corporate name, promissory notes, bonds, debentures, deeds of trust, and mortgages or other evidences of debt and securities therefore.
- e. To establish the criteria and procedure for admission to the corporation as a member of the corporation and retention of such membership status.

Section 3. ELECTION AND TERM OF OFFICE

Directors shall be elected at each annual meeting of members, or by ballot using internet communication or regular mail. If new Directors are not elected by the above procedures, the

directors may be elected at any special meeting of the members held for that purpose. All Directors shall hold office until their respective successors are elected. All Directors must be members.

Section 4. VACANCIES

Any vacancy or vacancies in the Board of Directors resulting from death, incapacity, resignation, expiration of term of office, removal or otherwise, shall be filled by the remaining Directors or Director then is office even though less that a quorum.

Section 5 PLACE OF MEETING

Regular meetings of the Board of Directors shall be held at any place within the County of San Diego, which has been designated by resolution of the Board, by written consent of all members of the Board or by internet communication. In the absence of such designation, regular meetings shall be held at the location of the monthly meeting of members for that month. Special meetings of the Board may be held either at a place so designated or as designated in the notice of such special meetings.

Section 6. ORGANIZATION MEETING

Immediately following each annual meeting of members, the Board of Directors shall hold a regular Board meeting for the purpose of organization, confirmation of the election of the elected officers, appointment of non-elected officers, and the transaction of other business.

Section 7. SPECIAL MEETINGS

Special meetings of the Board of Directors for any purposes shall be called at any time by the President or by any two Directors. Written notice of the time and place of the special meetings shall be delivered personally to each Director or sent to each Director by mail, internet communication,

or by other form of written communication, charges prepaid, addressed to them as shown in the records of the corporation Such notice shall be mailed at least 72 hours prior to the time of the meeting. If notification is less than 72 hours prior to the time of the meeting, the President or Directors calling the meeting shall telephone each Director and make a good faith effort to inform them of the meeting.

Section 8. PARTICIPATION BY TELEPHONE

Members of the Board may participate in a meeting through use of conference phone, so long as all members participating can hear one another.

Section 9. ADJOURNMENT

In the absence of a quorum at any meeting of the Board of Directors, the majority of the Directors present may adjourn the meeting until the time fixed for the next regular meeting of the Board.

Section 10. REMOVAL

The entire Board of Directors or any individual Director may be removed from office, with or without cause, by the vote of a majority of the total number of members.

Section 11. COMPENSATION

The Directors shall receive no compensation for their services as Directors, although they shall be reimbursed for actual expenses authorized by the Board.

Section 12. APPROVAL OF ACTIONS

The transactions of any meeting of the Board of Directors, however called and wherever held, shall be as valid as though occurring at a meeting duly held after regular call and notice, if a quorum is present and if either before or after the meeting, each of the Director not present signs a written waiver of notice or a consent to holding such meeting.

Section 13. ACTION WITHOUT MEETING

Any action by the Board of Directors may be taken without a meeting if all members of the Board consent in writing or by internet communication to this action.

ARTICLE IV OFFICERS

SECTION 1. OFFICERS

The officers of this corporation shall consist of 15 officers elected as Director-Officers by the members and such other officers as may be appointed by the Board of Directors. The 15 officers elected as Director-Officers by the members shall be a President; 1st Vice President, Information Systems; 2nd Vice President, Programs; Gallery Manager; Floor Art Chair; Monthly Show Chair; Newsletter Editor; Treasurer; Membership Chair; Publicity Chair; Web Site Chair; Recording Secretary; Parliamentarian; Hospitality Chair and Wall Art Chair. When the duties do not conflict, one person may hold more than one of these offices, except President and Recording Secretary. Officers elected by the members must also have been elected as Directors; other officers as the Board of Directors may appoint, need not be members of the Board of Directors but must be members of the Corporation.

Director-Officers shall serve no more than three (3) consecutive terms in the same office except the President. A term of office shall be defined as one fiscal year.

Section 2. ELECTION

All 15 Officers elected by the members as Director-Officers shall be so elected at the annual meeting of members, or other approved form of ballot, for a term of one year. The President shall not serve more than two consecutive terms.

Section 3. VACANCIES

A vacancy in any elected office because of death, resignation, removal, disqualification or otherwise shall be filled by the Board of Directors.

Section 4. PRESIDENT

Subject to the control of the Board of Directors, the President shall have general supervision, direction and control of the business and affairs of the corporation. She or he shall preside at all meetings of the members and Directors and shall have such other powers and duties as may be prescribed from time to time by the Board of Directors. She or he shall set the agenda and preside at all meetings of members and meetings of the Board of Directors. The President shall, subject to the approval of the Board of Directors, appoint chairs of standing committees and the nominating committee, and shall be ex-officio member of all community except the nominating committee, and shall further represent the Guild in all community affairs and activities concerning the Guild, either in person of by a designated agent.

Section 5. 1st VICE PRESIDENT, INFORMATION SYSTEMS

The 1st Vice President, in the absence or disability of the President, shall perform all the duties of the President, and when so acting shall have all the powers of, and be subject to the restrictions upon, the President. The 1st Vice President shall be responsible for all databases, forms and publications requiring the use of a computer, and for scheduling the staffing of the gallery. The 1st VP shall maintain all databases for customers and membership if the chairs for these programs do not have access to a computer. The 1st V P. is a member of the Gallery Committee and shall perform such other duties as may be prescribed from time to time by the Board of Directors.

Section 6. 2nd VICE PRESIDENT, PROGRAMS

The 2nd Vice President shall act as Program Chair for the monthly membership meetings and shall have such other powers to perform such other duties as may be prescribed from time to time by the Board of Directors. Specific duties include, but are not limited to, selecting the

guest artist demonstrator, making arrangements for such demonstrations, and arranging the Annual Holiday Party.

Section 7. GALLERY MANAGER

The Gallery Manager shall select and head the Gallery Committee. The Gallery Manager is responsible for recommending policy changes concerning the Gallery to the Board of Directors, for the smooth and efficient operation of the gallery, for expenditures of funds not to exceed \$100 per calendar month for purchase of gallery supplies and for recommending to the Board of Directors for expenditures exceeding his or her authority, for training gallery staff in gallery operations, for selection and training of the Gallery Chair of the month, for overseeing all special art shows, and for such other duties as pertain to the office or as prescribed by the Board of Directors from time to time.

Section 8. FLOOR ART CHAIR

The Floor Art Chair is a member of the Gallery Committee and has the ultimate determination on Floor Art selection. All forms and instructions pertaining to Floor Art are the responsibility of the Chair. Implementation of policy and recommendation in policy changes concerning Floor Art to the Board of Directors are the responsibility of the Chair. The Floor Art Chair shall discharge all the duties as pertaining to the office or as prescribed by the Board of Directors.

Section 9. MONTHLY SHOW CHAIR

The Monthly Show Chair shall arrange and direct all Monthly Art Shows, shall be responsible for monitoring quality and for implementing all policies of the Board of Directors in regard to Monthly Art Shows. The Monthly Show Chair is a member of the Gallery Committee. The Monthly Show Chair shall work with all Special Show Coordinators, i.e. in providing advice on the hanging of the show, awards, selecting judges for all shows (except special shows), and assisting the judge with placing ribbons and recording his or her choices. The Monthly Show Chair shall discharge such duties as pertain to the office or as prescribed by the Board of Directors from time to time.

Section 10. NEWSLETTER EDITOR

The Newsletter Editor shall be responsible for publishing and distribution of the "Paint Rag", the Guild's monthly newsletter. The Editor may arrange the newsletter as required to get it published on a monthly basis. The Newsletter Editor shall have such other powers and perform such other duties as may be prescribed by the Board of Directors.

Section 11. TREASURER

The Treasurer shall receive and safely keep all funds of the Corporation and deposit same in such bank or banks as may be designated by the Board of Directors. Such funds shall be paid out only on the check of the Corporation signed by the President, Gallery Chair, Recording Secretary, 1st Vice President, Treasurer or other such officers as may be designated by the Board of Directors as authorized to sign the same. The Treasurer is responsible for submitting the proper paperwork to an accountant for computing federal taxes and for submission of the proper paperwork to the state and federal governments. The Treasurer is responsible for producing for the members an annual financial statement within 90 days after the close of each fiscal year, which accurately reflects the current financial position and financial transactions of the Corporation. The Treasurer shall keep and maintain adequate and corrects books of the accounts showing the receipts, and disbursements of the Guild, an account of its cash and other assets, if any, provide a monthly financial update for the Board and an annual budget. Such books of accounts shall, at reasonable times, be open to inspection by any member or Director. The Treasurer shall have such other powers and perform such other duties as may be prescribed from time to time by the Board of Directors.

Section 12. MEMBERSHIP CHAIR

The Membership Chair shall be in charge of all membership drives, for renewing honorary memberships, signing Membership cards, for publication, with assistance of the 1st Vice

President, of the Membership Directory on an annual basis, for supplying mailing labels as needed, for Membership Application Form update and availability and update of the Gallery Roster with new member information and publication in the newsletter of new member information. If the Membership Chair does not have access to a computer, she or he will coordinate requirements for same with the 1st. Vice President. The Membership Chair shall perform such other duties as may be prescribed from time to time by the Board of Directors.

Section 13. PUBLICITY CHAIR

The Publicity Chair shall arrange for all publicity for the Guild, write press releases, write public Service Announcements for free publicity, arrange for paid ads previously approved by the Board of Directors, recommend additional paid ads to the Board of Directors, shall coordinate publicity with the artists, Floor Art Chair, Wall Art Chair and the Gallery Manager, and shall perform such other duties as may be prescribed from time to time by the Board of Directors.

Section 14. WEB SITE CHAIR

The Web Site Chair shall maintain and update the Guild's Web Site, maintain the domain names, "sandieguitoartguild.com" and "offtrackgallery.com", and shall perform such other duties as may be prescribed from time to time by the Board of Directors.

Section 15. RECORDING SECRETARY

The Recording Secretary shall keep and maintain at the principal office of the Guild, a book of minutes of all meetings of the Board of Directors with the time and place of holding, how called or authorized, the notice thereof given, the names of those present at Board of Directors meeting and the proceedings thereof. The Recording Secretary shall have custody of the Seal of the Corporation and shall perform such other duties as may be prescribed from time to time by the Board of Directors.

Section 16. PARLIAMENTARIAN

The Parliamentarian shall call the first meeting of the Nominating Committee and shall preside at the meeting until a Chair is elected. He or she shall assist the President in parliamentary procedure, shall keep a record of all motions, seconds to motions and outcome of votes taken by the Board of Directors and at the Annual General Meeting of Members for future use and reference. The Parliamentarian shall be the outgoing President, unless the outgoing President is nominated to another job. In such an instance, the nominating committee shall nominate another member of the Guild for this position. The Parliamentarian shall perform such other duties as may be prescribed from time to time by the Board of Directors.

Section 17. HOSPITALITY CHAIR

The Hospitality Chair is responsible for refreshments for all general meetings, all gallery receptions and shall perform such other duties as may be prescribed from time to time by the Board of Directors.

Section 18. WALL ART CHAIR

The Wall Art Chair is a member of the Gallery Committee and has the ultimate determination on Wall Art selection. All forms and instructions pertaining to Wall Art are the responsibility of the Chair. Implementation of policy, and recommendation of policy changes concerning Wall Art to the Board of Directors are the responsibility of the Chair. The Wall Art Chair shall discharge all the duties as pertaining to the office or as prescribed by the Board of Directors.

ARTICLE V NOMINATING COMMITTEE AND ELECTION PROCEDURES

Section 1. APPOINTMENT OF COMMITTEE

The president shall appoint a Nominating Committee of three individuals who must be members, but only one shall be an elected Director. The Nominating Committee shall propose a slate of at least one candidate for each of the 15 Directors for election at the annual meeting

of members. The members of the Nominating Committee shall not nominate themselves for such positions. In addition, any member of the Nominating Committee may make nominations for the positions of the 15 Directors.

Section 2. VOTING BY GENERAL MEMBERSHIP

Voting shall be by voice, show of hands, written ballot or by internet communication as determined by the Board of Directors. The Nominating Committee shall cause to be prepared an official ballot upon which shall appear the 15 elective positions on the Board of Directors and the names of all persons nominated under each. Only members shall be entitled to vote. Members shall be entitled to vote for one person for each of the 15 elected positions. The person receiving the highest number of votes cast shall be elected to each of the 15 positions being filled. In the event a majority is not received by any one person for a position on the first ballot, a second vote shall be conducted in a run-off election between the two persons who received the greatest number of votes on the first ballot, and the one receiving a majority shall be elected to the position. Tie votes shall be determined by the outgoing Board of Directors.

ARTICLE VI AMENDMENTS OF BY--LAWS

These By-Laws may be amended or repealed and new By-Laws adopted by the vote of a majority of the members of the Board of Directors at any Directors' meeting (except a By-Law fixing or changing the number of Directors may be adopted, amended or repealed only by the vote or written consent of a majority of a quorum at a meeting of members duly called for that purpose and which is the vote of the majority of those present and voting).

ARTICLE VII AUDIT

Section 1.

The Board of Directors shall ensure an independent audit of the financial transactions, cash accounts and tax filings have been completed annually. The purpose of this audit is to confirm the accuracy of the financial statements produced by the Treasurer. The selection of the auditor shall be made by the Board of Directors. This audit requirement may be satisfied, at the discretion of the Board of Directors, by a financial statement compiled independently and in accordance with standards established by the American Institute of Certified Public Accountants.

Section 2.

The fiscal year shall begin on September 1 and end on August 31.

ARTICLE VIII DISSOLUTION

Upon dissolution of the San Dieguito Art Guild, all membership dues shall be prorated and returned to the membership. The remainder of funds shall be donated to a nonprofit organization.

Earlier this year, trainee soldiers had their guns confiscated and replaced with sticks after a riot broke out between those who had been paid and those who had not.

The African Union, which has peacekeepers at Camp Jazira, temporarily suspended payments over fears that men who had been paid would be killed by those who had not, an official involved with the training said.

Soldiers also had problems with some battalionlevel commanders stealing their rations, a European official said.

The U.S. has sent a shipment of food this month to try to help the malnourished soldiers regain their strength, he added.

Both officials spoke on condition of anonymity because they were not authorized to speak to the media.

Siyad, the defense minister, said the U.S. was funding the salaries of about 1,800 Somali soldiers, and an additional 3,300 soldiers were being paid by other donors.






Needed: Shrink Wraps and Cards for Gallery

As a benefit of membership in SDAG, members are allowed to display shrink wrap prints in the Off Track Gallery. This is the policy for shrink wraps:

- Each member may put 2 pieces (up to 16" x 20" in size including mat) in the portable print racks.
- In addition, 3 pieces (up to 8" x 10" in size including mat) may go in the Art Rack near the
 office door.
- As soon as a shrink wrap is sold, it may be replaced.
- The artwork needs a mat board backing of the same size. This is then enclosed in a crystal clear envelope (which needs to be replaced or cleaned once a year). The total thickness of the resulting shrink wrap piece is not to exceed 1/4".
- The salesperson needs to see the artist's name, price, title of the piece and either "Original" or "Limited Edition Print" somewhere on the back of the piece.
- Members pay no charge to display shrink wraps; however, there is a 15% commission.
- Doreen Long is the shrink wrap coordinator.

Greg Evans is the creator of the nationally syndicated comic strip, LUANN, which appears in over 300 newspapers in the United States and abroad. Captivated by cartooning at an early age, he admits he was "Born with the 'toon disease". Raised in Burbank, home of Disney Studios, Greg dreamed of someday working for Walt, giving life to Mickey Mouse and Donald Duck. Even in elementary school, he entertained and amazed his classmates with accurate, spontaneous sketches of Disney characters. But then he discovered the newspaper comic page and decided he wanted to become a comic strip cartoonist. By the age of 12, he was creating his own comic strips. In 1970, he graduated from Cal State Northridge with a Bachelor of Arts degree. His major was art - not cartooning - but watercolor, printmaking and graphic design. Greg went on to get this teaching credential and secured his first classroom assignment at Central Union High School in El Centro, California, teaching art. He taught for four years, got married, traveled the world, lived in Australiafor two years and returned to Colorado Springswhere he landed a job as a graphic artist for a television station. Today, Greg lives and works at his home in San Marcos. A member of the San DiegoWatercolor Society, he grabs his easel whenever he gets the chance and heads out to paint San Diego County, LUANN was born in March 1985. 





Distinguished Digs

A modern blend of art and science

Home of Manuelita and Dr. Willie Brown

Like the sun breaking through June gloom, the modern home of Dr.Willie Brown and his wife, Manuelita, is delightful. Different sections of the exterior are painted yellow, red-orange and blue-gray. A distinctive awning of blue canvas shades a sitting area just outside of Manuelita's artist studio. Their landscaping includes a bountiful array of fruit and vegetables and is wonderful in its creative variety. A path winds around the house passing along fruit trees, a koi pond, a waterfall, colorful plants and sculptures. The Brown's have created a home that reflects their love of art, music, cooking and family.

They purchased the lot in Encinitas a decade ago and began working with architect Daniel Goudy to design their custom home. It was very important to us to make our home comfortable and accessible, explained Manuelita. The result is a modern 4,000 square-foot home that was influenced by architect Irving Gill, a San Diego architect who is considered a pioneer in the modern movement in architecture.

The main entrance is paved with flagstone, which leads through a unique wrought-iron gate. Inside, the walls are painted white and creamy-beige to create a backdrop to display a variety of art. Arched ceilings, pedestals, custom cabi-

nets and lighting add to the modern look of the interior.

Looking at their choice of building materials, solar panels and organic garden, it is obvious they are committed to a "green" lifestyle. Willie pointed out the water collection barrels he uses for watering plants. Solar panels and dual-pane windows help reduce their consumption of electricity. Use of "sustainable" materials, such as bamboo flooring, figures into their decision process in the design of their home.

Throughout their yard, they grow many fruits and vegetables that provide them with "local" produce. They have done most

of the work themselves, including a koi pond, with a wooden bridge. Fruit trees include orange, guava, fig, lime and nectarine. An enclosed vegetable garden was overflowing with lettuce, spinach, kale, tomatoes, corn, peas and strawberries. A grapevine covers a trellis along the path to the backyard. Something fresh is always in season and often saves them a trip to the grocery store.

The Browns enjoy cooking and prepare most meals at home rather than going out to restaurants. For cooking, there are two Viking gas stoves and two electric convection ovens. Their spacious kitchen has granite slab counter tops and maple cupboards. Beautiful art pieces adorn the wall, as they do throughout the house.

Manuelita is a renown artist whose primary medium is sculptures in bronze. Her sculptures, as well as pieces from other artist friends, are displayed throughout their home. Her studio is filled with her artist tools and sculpture projects in various stages. The spacious studio leads to a secluded patio area with wicker chairs.

At University Town Center, her playful sculpture, "Almas de Mar", depicts dolphins jumping. At UCSD, her "Triton" sculpture is impressive and a popular photo opportunity among students and visitors alike.

Dr.Willie Brown is a professor of microbiology at UCSD. He has spent the last three summers teaching at Yousei University in Seoul, South Korea. He also loves to listen to music and designed the grand room of his home with rounded corners, specifying the length of the room for the best acoustics possible. Speakers are installed in the ceiling of the dining room, study and kitchen so that music can be heard throughout the house. The Brown's have two grown children, Marvin and Vince.

Encompassing a wonderful blend of art, music and design, coupled with its peaceful outdoor setting and garden, it's the perfect foundation for harmonious living.

MTRP Art Program

The Mission Trails Regional Park Foundation offers opportunities for visual artists to display thei work. Currently, these displays are limited to paintings and photography by small or large group and solo artists. Each year the MTRP sets aside one exhibition for artists wishing to exhibit, bu who are not part of a group and who do not wish a solo exhibition.

Displays of artwork are rotated every four weeks throughout the year. Regardless of the media certain criteria must be followed as outlined by the Mission Trails Regional Park Foundation.

Artists, who exhibited in 2010, may apply in 2011 only for an exhibition different from thei previous year's show. For example, a Solo Artist in 2010, may apply for a Group Show in 2011, and a Member of a Group Exhibition in 2010 may apply for a Solo Show in 2011. Artists, who skip a year, may apply for either a solo or group show regardless of his/her previous exhibition Exception: Artists may apply in the Solo/Group category every year.

Due to growing interest in exhibiting work in the Mission Trail Regional Park Visitor & Interpretive Center, applications will only be available and accepted every year from May 1st -June 30th for the next exhibition year.

All applicants, whether requesting a solo exhibition or as part of a group, must be juried by the MTRP Art Committee. The MTRP Art Committee is comprised of professional artists are photographers as well as individuals representing the MTRP Foundation. Artists are notified or either acceptance or non-acceptance by email.

Beginning in 2011, artists applying for an exhibition in MTRP MUST have a valid email address in order to be juried. Artists who do not have an email account are encouraged to acquire an accoun at a local library or seek assistance from a friend or family member.

 - a. The sign will look like the header on the website with the brush stroke and Off Track Gallery in large letters. It will also include "San Dieguito Art Guild Est. 1965"

- in small letters below the name.
- b. The sign should be made similar to those at Becker Surfboards with the 3 dimensional mahogany frame and letters inside.
- c. Dave will get a price on the sign for the board meeting.
- 4. The committee unanimously agreed that in the event that a staffer does not report for duty the following rules apply:
 - a. First offense is a fine of \$45. The fine would come from the staffer's deposit, which would need to be repaid within 3 days. The deposit would be repaid in person or by mailing to the gallery to the attention of the calendar chairperson. If not received in a week the violators art would be remove from the gallery and that space given to an artist on the waiting list.
 - b. If an artist had a second offense they would forfeit their deposit and their artwork would be removed from the gallery. Their space would be given to another artist on the waiting list.
 - c. Only the calendar chairperson can approve any changes to the schedule. All calendar changes must be approved by the calendar chairperson! Other board members are not authorized to make changes to the schedule or policy regarding staffing.
- 5. Art that appears in the gallery which was not juried in must be removed. It should be brought to the attention of the appropriate chairperson who will have the artist remove the art. Art that is of questionable quality is at the discretion of the appropriate chairperson as to whether it meets gallery standards. Artwork that is questionable as to whether the artist was juried in for the particular medium must be brought before the gallery committee for a determination. Ella Salmi's mosaic pieces were juried in artistically with the requirement that the tacky nature of the pieces be eliminated.
- 6. Without exception all artists are required to keep their art within their own space. This includes all wall art and floor art. Labels, business cards and tags are not permitted

- outside of the artist's rented space.
- 7. No artist is allowed to write their own receipt for gallery rental. If at the end of the rotation (Friday at 8pm) an artist has not paid their rent and scheduled their staffing dates or made arrangements with the appropriate chairperson to do so, then their artwork is not to be displayed in the gallery. There will be a three day grace period where the artist must make arrangements with the chairpersons or their art will be placed in the back room by the gallery committee and the gallery assumes no responsibility for damage. That space will be rented to another artist on the waiting list.
- 8. The GC recommends limiting display space in out gallery to artists who reside in San Diego County. Our mission is to provide a place for emerging artist to display their artwork. Artists who have been in the guild and move out of the county are allowed to remain as long as they continue to comply with the requirements. No new artist from outside the County will be allowed to display in the gallery as there are more than enough artists in our county to sustain the gallery.

(Rita had to leave the meeting at this time)

- 9. The Monthly Show was discussed and the following was agreed upon:
 - a. The pricing structure will remain the same as existing; Ricki may propose changes in the future. If more space is needed for 3D art the MS can expand into another large cube bank. It will be located further into the back of the gallery where space is available.
 - b. If in the future an artist moves any piece in the MS the piece will be removed from the show. No one is allowed to relocate or change any artwork in the MS without the prior approval of the MS chairperson.
 - c. All artwork displayed in the MS cannot be duplicated elsewhere in the gallery. This includes prints, gicles or other formats.
 - d. If a piece of artwork has won a ribbon in the MS it is no longer eligible to reenter the show.

- 10. The gallery committee does not recommend sales incentives for the staffers. We believe that first we should improve our training and observe the impact on sales. Any sales incentive would involve additional work to implement and operate. The gallery committee would prefer to solicit more feedback from our patrons. This could be accomplished similar to how COAL does. They display a piece of art that will be raffled to a patron who fills out the survey sheet. The survey asks them to select their three favorite pieces in the gallery. This survey also provides input to the artists.
- 11. A discussion of the rotations resulted in agreement that we should have all of the chairpersons present when we make decisions about the rotation. Rotation will be the first item discussed at the next GC meeting.
- 12. Also added to the next agenda will be the idea of relocating one bank of large cubes to one of the windows so that the gallery does not look like a jewelry store from the outside. This would be a more equitable arrangement for the non jewelry artists.
- 13. The gallery committee agreed to offer free space on a one time basis to the past presidents who were featured for the 45th anniversary celebration. The two remaining hanging frames, one bank of large cubes and if necessary the Soravia space will be allocated for the reception to showcase the work of the featured artists. Dave will communicate this opportunity to the eight featured artists. In the future free gallery space will not be offered to featured artists, this opportunity is in recognition for contributions of these past presidents.

The meeting was adjourned.









- 1. Gallery Wallcovering: The Gallery Committee recommends that we extend the wall coverings at least around the corner to cover the wall between us and the restrooms. We have the material in Kirkos' storage building and the wallpaper hanger will charge \$150 to do the work. If we wanted to also cover the front wall his fee is an additional \$175. I think we have enough material for the entire job but do not know for sure until we open the box.
- 2. Gallery Sign: The Gallery Committee recommends that we proceed with procuring a sign similar to those at Becker Surfboards. I have contacted the fabricator and he said to budget \$1100 for the sign. He is preparing a formal proposal and attached is his preliminary design. We would still need to:
 - a. Submit the proposal to the landlord. We are complying with the specs so I would not anticipate a problem with Cornerstone.
 - b. Obtain a sign permit from the City.
- 3. Gallery Handbook: Attached is a revised edition of the Gallery Handbook which incorporates all revisions as of today (Saturday). I recommend we authorize then publication of the handbook both in print (100 copies) and on the website. We could have them ready to distribute during the training sessions.
- **4. Gallery Committee Meeting**: The gallery committee meeting minutes are attached for your information.
- 5. Gallery Renters: We have several gallery renters who are habitually difficult to collect rent and get to staff and volunteer. I personally am tired of hounding these people and I am sure the wall and floor chairs are also frustrated. These few individuals make a significant amount of extra work for the Gallery Committee. I recommend that in the future if a renter has not paid and signed up to staff by the last day of the rotation their space is given to the next person on the list. It should <u>not</u> be the responsibility of the chairs to be bill collectors, but the responsibility of the renter to fulfill their obligations. I recommend this be enforced at the next rotation.
- 6. Gallery Operations: I recommend that the Gallery Manager be given a \$200 cash advance which he would use to fund the operation of the gallery. Each month the GM would submit his expenses and get a check for the amount that was spent to maintain the gallery. At the end of the term the GM would return the \$200. I do not believe it is fair to require a volunteer to fund the operation of the gallery out of their own personal funds.
- 7. **Motions**: I would like to make the following motions:
 - **a.** I move to contract with Mark Snyder (the wallpaper hanger) to install wallpaper on the wall between us and the restrooms.
 - b. I move to approve the purchase and installation of a new sign similar to those at Becker Surfboards as detailed in the preliminary design. The maximum amount to be spent would be \$1500 which would include the sign, sales tax and the permit fees.
 - c. I move to approve the Gallery Handbook and authorize the publication of the handbook in print and on the website. The maximum amount to be spent on the printing would be \$150 which would include sales tax.
 - d. I move to authorize the GC to remove and replace all gallery renters who do not fulfill their obligation to pay rent and sign up for staffing by the last day of the rotation.
 - e. I move to set up a \$200 cash advance for the Gallery Manager to use in procuring the necessary supplies to keep the gallery operating smoothly and efficiently. Each month the GM would submit an Expenditure report with receipts for reimbursement. At the end of the GM's term the \$200 would be turned over to the next Gallery Manager.





San Dieguito Art Guild Mission Statement

The San Dieguito Art Guild is an organization dedicated to furthering artistic understanding and fostering artistic growth of members and the community at large by promoting interest, education, knowledge and skills in the visual arts.

Background

The San Dieguito Art Guild (SDAG) was founded in 1965 by a group of forward thinking artists who wanted to "engage primarily in the promoting and understanding of art in the community". They also wanted to "provide a place for artists to display their work, establish a scholarship fund for young artists, and to further maintain a gallery workshop for members."

SDAG is a non-profit organization 501(c) 4 dedicated to furthering artistic understanding in the local community. SDAG is managed and operated entirely by its members. SDAG is committed to fostering the artistic growth of individual members through social and educational events. SDAG exists whether or not there is a gallery.

General membership meetings are held quarterly. SDAG is managed by its Board of Directors. The Board of Directors is elected by the membership annually at the Annual Membership Meeting. Board meetings are held on the fourth Monday of the month. A current roster of Board Members and a meeting calendar are available on the website. Since its founding in 1965 SDAG has operated the Blue Lantern Gallery, The Chateau Gallery and two other galleries in Del Mar. The guild moved to Leucadia in 1976 and took over the Off Track Gallery in 1994 when the two entities became one. After three more moves, the Off Track Gallery, owned and operated by the San Dieguito Art Guild, has a permanent home in the Lumberyard Shopping Center in downtown Encinitas. The gallery is operated for the purpose of showcasing the work of SDAG members. Artwork in a variety of mediums including digital art, watercolor, oils, sculpture, photography, acrylics, mixed media, glass, fiber, pastel and jewelry are displayed and for sale.

Benefits of Membership in the Guild

Membership in SDAG is a rewarding experience and provides numerous benefits. SDAG members pay annual dues. Membership is renewed every September 1st. To be in the Guild Directory dues must be paid by October 1. New members joining in the preceding months of July and August are considered paid up through the following year. Membership fees vary based on type of membership. Please refer to the website, www.offtrackgallery.com or contact the Membership Chairperson for current information. There are many opportunities to interact with fellow members both at Guild sponsored functions and on a day-to-day basis at Off Track Gallery. Many loving and lasting friendships have formed between fellow SDAG members over the course of its rich history. Valuable learning experiences, personal motivation and inspiration are another wonderful benefit of membership in SDAG. Some of the membership opportunities are listed below (for more information on any of the following, please refer to the website, www.offtrackgallery.com):

<u>Environmental Painters</u> - The Environmental Painters meet regularly in local areas such as Torrey Pines State Reserve, Del Mar, San Diego Botanic Garden and Batiquitos Lagoon.

<u>Paint Rag</u> - SDAG's monthly members' newsletter includes a calendar of upcoming events, news about its members, shows, gallery news and other opportunities. Advertising opportunities are also available for a small fee.

<u>Website</u> - SDAG maintains a website, <u>offtrackgallery.com</u>. Members may have one thumbnail of their art work posted for free on the website. Members may also have their own web page on SDAG's website for a nominal fee. Please contact the Website Chair for more information.

<u>Card Racks</u> are available to all members to display their cards, based upon availability of space. Cards placement is managed by the Card Rack Coordinator. <u>Shrink Wrap Bins</u> - Shrink wrap bins and racks are available to all members to display their original artwork and limited edition copies of their original artwork. The bins are limited in number and space so the quantity of pieces allowed for each member is also limited. The Shrink Wrap Coordinator manages the bins and racks.

<u>Continued Learning</u> - Members may attend free demonstrations sponsored by SDAG. The demonstrations given by well-known artists are entertaining and provide a wealth of information. As part of SDAG's community outreach demonstrations are open to the public at no charge.

<u>Monthly Art Show</u> - The Monthly Art Show is a non-juried show where members display and sell their artwork. Entries are judged and ribbons are awarded in several categories. A cash award is made for the entry selected as Best of Show. Judges are artists from outside SDAG membership and are well-known local artists. Reproductions of original artwork are accepted but are not eligible for ribbons or cash awards.

<u>Annual Small Image Show</u> - Each December, in lieu of a Monthly Art Show, SDAG has its Small Image Show. This is a non-juried show. Entries are judged and ribbons are awarded for Best of Show, First, Second and Third places in five categories. Cash awards are given. The show is open to both members and nonmembers and is timed for the holiday shopping season.

<u>Gallery Space Rental</u> - SDAG members are encouraged to show and sell their original art work and prints at Off Track Gallery. Members may rent wall or floor space in the gallery. Detailed information on renting gallery space can be found later in this handbook.
